Dear Gaesdonck-families

the first days of school are behind us and again you receive a parents letter. We promise not to continue this frequency. However, we do have some updated information:

Of course, these first school days were unusual in several respects: besides the heat wave, the compulsory wearing of face-masks as introduced by the state government made the lessons very special. Looking back, we can say this time as well: nothing is served as hot as it is cooked or as it was passionately discussed in advance, not least in the media. The world did not stop turning around and everything went well. Many teachers and their classes took advantage of the wide possibilities of the campus, sat in the shade with the children and took many breaks.



All in all, there was a relaxed, positive atmosphere on the whole site despite the heat. Many thanks to all who helped and especially to your children: our students, at all ages, adhered to the unusual rules and regulations with great discipline. Especially our little ones did a great job!

Routes/Zones

As already communicated in the last parents letters, the division of the campus into school and living areas is still a central element in the Corona-protection concept for our students in the two forms of boarding school. Entering the boarding school area is still not possible or only in exceptional cases. This zoning is a binding part of the school and boarding school regulations until further notice!



With validity from 17.08.2020 the way between the rear car park and the sports field behind the canteen is open for all students again. However, the adjacent green areas (orchard meadow, Trevi pond, area around the lake) continue to belong exclusively to the residential area of the boarding school or day-time boarding school. Access to the smoking area is free for external students over 18 years of age within the framework of the current regulations for short stays.

Unfortunately, the cloister, a popular shortcut from the rear car park to the school building, must also remain closed to external students! The zoning valid from Monday is as follows:
